Resolution for DCNR Grant

The Western Pennsylvania Conservancy approached the COG to see if we wanted to partner with them on a grant opportunity for Pitcairn Borough and Braddock Borough. These two communities have combined sewer and storm water systems. The COG would be the grant applicant and administer the funding. The WPC has completed a number of "Green Scans" in three different communities in Allegheny County. The WPC looks at current green spaces in the communities and makes recommendations for additional green spaces and storm water management projects that may be used as credit with the EPA. The Green Scans will involve field inventories of existing green assets, including tree inventory, an assessment of community access to open spaces and outdoor recreational activities, and an evaluation of opportunities to use green infrastructure for storm water management solutions. The Green Scans have helped communities secure additional grant funding and loans to implement their recommended projects. A motion to pass a resolution to allow Amanda Settelmaier, as Executive Director, to submit a C2P2 grant to DCNR on behalf of the Turtle Creek Valley COG was made by Chad, seconded by Max. Motion passed unanimously.
