# Manager's Meeting: September 15, 2021 at 10am - Monroeville Community Park

Seth Abrams asked the group if they would be interested in further investigating the possibility of creating a revolving loan fund that would provide low interest loans to residents for home improvements. It could be potentially be managed by an organization like MVI or TCVCOG. Some preliminary thoughts were discussed, and everyone in attendance was in favor of getting more information. Amanda brought up the Allegheny Home Improvement Loan Program that currently exists and is run by RAAC. Whereas the RAAC program requires funds to be allocated toward the correction of code violations, the group preferred to more pro-active approach to thereby avoid potential future violations.

Amanda agreed to research the current program, and the possibility of receiving HOME funds for this purpose.

### **Police Testing**

The TCVCOG conducted a joint police test on Tuesday, September 14<sup>th</sup> with Amanda filling the role of Bill Gamble. There were 11 original applicants. Ten tested, Nine passed the physical agility. The test results have been received and forwarded to each participating Chief and Manager.

#### **Land Care**

Unkempt lots are unsightly, lower property values, and harbor unwanted wildlife & garbage. Recognizing that maintenance is time consuming, the TCVCOG is attempting to piloting a multimunicipal grass maintenance program next Spring. The theory is that high volume grass cutting will maximize volume "buying" while freeing up public works time to accomplish higher level tasks. TCVCOG intends to provide experienced and fully insured contractor(s) to offer a code-compliant cutting service to vacant lots and vacant properties( with structures). It is important to note that cuts will be code compliant, but NOT manicured. Cut grass removal, if desired, will invoke a debris removal fee.

The TCVCOG is offering this program in an attempt to solve a problem shared across municipal boundaries. It is recommended that you break out the total actual hourly cost of your DPW workforce: wages, benefits, equipment operation/repair, etc., and multiply that number by DPW hours spent cutting. When evaluating value, you may also want to consider DPW tasks that aren't being accomplished due to time spent grass cutting. If you determine it's valuable to proceed, we ask your town to submit a parcel map with the sites marked, and a list of property addresses, corresponding lot & block numbers, and the frequency of cuts that you would want. We will then get quotes to determine pricing before asking you to commit.

### Goals of the program:


- Free up DPW time to complete other important tasks
- Eliminate equipment repair and maintenance costs for all contracted grass cutting
- Ensure code compliance of Vacant Lots, and reduce complaints from neighbors regarding harborage of unwanted wildlife.

Contractors will provide the TCVCOG with a Certificate of Insurance (COI) listing the municipality as additional insured. The contractors will provide all equipment, material, fuel, and, as needed, proper disposal of any debris.

The TCVCOG will be responsible for administration of the contract and quality control to ensure codecompliant cuts:

- The TCVCOG will issue GPS work orders to the contractor.
- The contractor will be required to supply the TCVCOG with before pictures (4 ea) and after pictures (4 ea) prior to any payments being released.
