- Amanda gave updates on upcoming meeting dates & topics.
- Police Training Fall dates are to be determined. Possibly in October
- Vactor Amanda Encouraged towns to start scheduling their dates.
- Whole Home Repair Program opened on May 30<sup>th</sup>. These are ARPA funds that will pay up to \$50,000 for home repairs for low-income property owners. Amanda encouraged all to make this program aware to their municipalities.
- Amanda is in the process of scheduling a meeting with Summer Lee's office to discuss incorporating analytics to the CodeNforce program that could be helpful to the County, as well as a potential partnership that could sustain the system long term.

# The Allegheny County Comprehensive Plan

Matt Trepal, AICP, Planning Division with Will McLain gave a presentation regarding the development of the new Allegheny County Comprehensive Plan. The previous plan was discussed and the intention of avoiding past failures with the previous plan.
